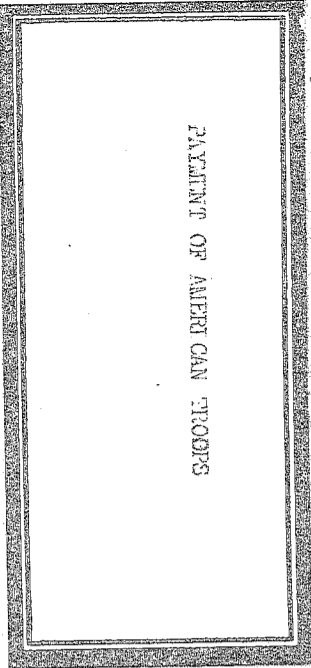

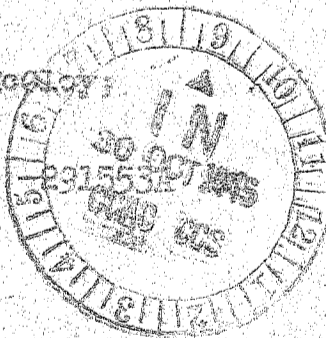

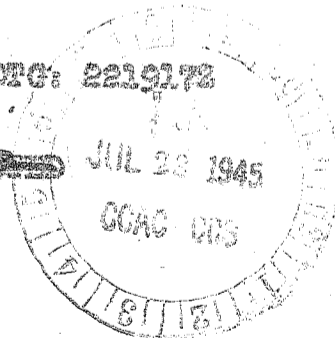

Principle of paying United States military personnel
without corresponding charge to War Dept appropriated funds
is not acceptable. Such procedure would be contrary to
established United States policy whereby Congressional control
over such expenditures is maintained. This policy is
without prejudice to determination of occupation costs and
settlement therefor.

Accordingly you are not authorized to pay United States
enlisted men serving as stenographic reporters in mil govt
courts extra compensation out of mil govt funds.

Following proposed revision of para 1, AR 35-4120 now
being processed thru War Department so that United States
military reporters may be compensated for mil govt court duty
on same basis as for courts martial and military commissions:
"The term 'court' as used in these regulations will be
understood to mean court martial, court of inquiry, military

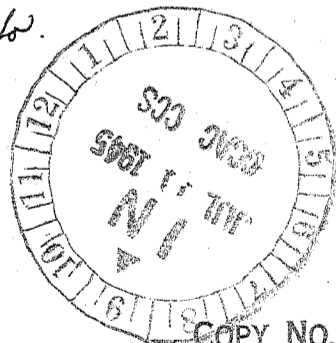

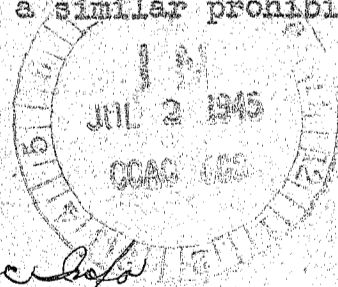

S 94242 from SHAEF Main to AGWAR for Combined Chiefs of Staff repeat for information to AMSSO for BCS signed Tedder this is VOG 544.

Payment of enlisted men detailed to serve as stenographic reporters for Military Government Courts in US Area of occupation is problem. Number of competent stenographic reporters in theater is small in relation to impending task and it is important that they work with the highest efficiency and be adequately compensated for the long extra hours they must work requisite to the proper speed for the dispatch of the business of such courts. Such service before Military Government Courts is in all respects comparable to such service before courts martial or Military Commissions, for reporting trials in which latter tribunals additional compensation is authorized (para 2, Army Regulations 35-4120). There is no similar authorization of compensation for stenographic reporters for Military Government Courts nor is such compensation regarded as permissible by SERVJAG (SPJCW/1945/2971, 1st indorsement to Fiscal Director). Payment for such service from Military Government funds would be appropriate and permissible except for Combined Chiefs of Staff Directive on Military Government in Germany which is interpreted as prohibiting the use of Military Government funds for the payment of Military personnel. The Joint Chiefs of Staff directive (JCS 1067) does not contain a similar prohibition.

Except where expressly authorized by law extra allowances or compensation may not be received by Military personnel detailed as such.

It is urgently recommended that CCS make exception to above noted prohibition so that enlisted men of the Army may receive extra from Military Government funds for serving as stenographic reporters in Military Government Courts, as essential to the effective functioning in the US Area of such tribunal.
